



As I walked the property of Ruddick Commons with Bob Felch and other board members in July, I could only think what a great accomplishment the purchase of this key piece of land was for the 'Sconset Trust.

In the near future, there will be walking trails and parking so another gem within the village will be enjoyed by all for years to come thanks to the extreme generosity of the members of the Trust who have given to the land campaign.

As we look forward to the 30th anniversary of the 'Sconset Trust, there remain both opportunities and challenges. We remain vigilant and ready to act if the U.S. Coast Guard decides to sell the LORAN property. The Board and selected leaders are pushing private and public solutions to the protection of this last

big piece of land as part of our "protect the greenbelt" strategy.

On a more worrisome note, the Baxter Road bluff is at the mercy of the whims of Mother Nature. Political, environmental and personal discussions with property owners continue and the 'Sconset Trust will continue to be involved as a landowner of approximately 13 acres at the North end of Baxter Road as well as our crown jewel, the Sankaty Lighthouse.

I thank all of you for your enthusiastic support of the Trust that magnifies our impact and reinforces what makes our village a special place. We also are fortunate to have dedicated Board members who work diligently on the issues facing the trust as well as fundraising. The 'Sconset Trust is in excellent shape due to the work of my predecessor **David Cheek** and the always incredible **Bob Felch**, the gala chairs **Doug and Patti Brown** and silent auction chairs **Elliott and Barbara Gewirtz**, the Coffin Capital Campaign chairs **Rhoads and Marcella Zimmerman** and our advisor **Betsy Grubbs**. Our efforts this year exceeded our goals and show what a dedicated group of people can really do.

Land Update

Land Report

The Trust has been very busy this summer working on its various parcels as well as monitoring the Loran property, currently owned by the Coast Guard.

The Baxter Road SBPF has also become of great interest to us as we are the owners of one of the largest parcels of land along the 'Sconset/Baxter Road bluff.

'Sconset is a very important hamlet for all of us. Our mission is to preserve as much land as we can in the 'Sconset environs and to try and create a community for all of us to enjoy for many generations to come. We had a wonderful year in 2012 when we were able to purchase the beautiful Coffin Land, which we have renamed Ruddick Commons. In raising the money for the land we told our wonderful donors, we would try to do something with the land to allow the community to enjoy access and utilization of that parcel as well as the adjoining Saunders parcel on Burnell Street. After walking the parcel with a committee from the Trust as well as members of the professional community who have had prior experience with these types of open land, we have concluded that the best utilization for it is to allow nature paths to be constructed on the site. It is our hope that for many, this will give pleasure, a recreational use and appreciation for the beauty of the land. We have asked the land surveyor to give us a total plat with elevations and wetlands delineated and from that, we will design and then construct walkways throughout the parcel without creating a commercial environment. There are wonderful natural visions for all of us to enjoy for

ourselves and for our ever growing families. We hope this project will be finished for our use in early spring 2014.

As we were all happy to see this summer, the Coast Guard took down the unattractive and obsolete LORAN Tower. The Coast Guard is deciding whether this land is truly surplus, and if so, what will they do to dispose of the asset. We monitor this progress, slow as it is, on a weekly basis. We communicate with the Coast Guard as well as our local Congressman Keating to try to push the disposition of the land toward conservancy. To date Keating has been sympathetic to our calls and has been most helpful. It is hoped he will be able to bring some legislation to the Congressional floor which may assist us in the preservation of the land for open space. Others have interest in the land such as the Town of Nantucket which utilizes the out buildings on the property as well as the Sewer plant for 'Sconset. We will continue to work hard to make sure this puzzle comes to a successful conclusion. Time will tell if our efforts will bear fruit.

The Trust believes the work of SPBF is beneficial to our preservation of the Sankaty Lighthouse. We have given them verbal support and we will watch to see if we may someday be included in the preservation efforts of that group. Right now we are not part of their current preservation effort, but with the course of nature as we have seen it the past decade or so, it may be inevitable that we become part of the plan to preserve Baxter Road and our access to the Lighthouse. This is another item we will need to monitor closely.

A closing note, if any of you see a parcel of land in need of future preservation, please let us know and we will try to assist in moving it along the proper path. Preservation is a community effort and we need everyone's help for 'Sconset to continue on this path. We appreciate all your generosity and continuing support of our mission statement committed to the preservation as the 'Sconset we have known for many generations.

The **Lourie Family Preservation Award** was presented to **Amos and Barbara Hostetter** for the renovation of their guest house "Flaggship." With the guidance of Bentley Churchill Architects, the home was carefully restored to its original footprint. In a time when most are increasing their home's size, the Hostetters removed the library on the north side to return the structure to it's proper scale. We applaud the Hostetter's for this sensitive renovation.

The **Tradesman Preservation Award** was awarded to **Bentley Churchill Architects** for their passion for preserving historic architecture. In addition to Flaggship, their work throughout the village was recognized. Elizabeth Churchill accepted the award posthumously for David Bentley.
